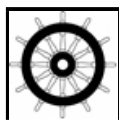

"Luxboard A aluminium honeycomb panel"

consisting of an approved non-combustible aluminium honeycomb core with aluminium sheets adhered to each side.

The aluminium honeycomb core of thickness between 5.0 mm and 38 mm (density 60 kg/m³) covered on both sides with aluminium sheets of thickness between 0.5 mm and 1.0 mm (density 2700 kg/m³) which are glued to the honeycomb core with 0.12 mm of approved adhesive thermoplastic film LBA125.

Total thickness: 6 mm - 40 mm

Application/Limitation

Approved for use as low flame spread material, not generating excessive quantities of smoke nor toxic products in fire.

Approved for use as decorative veneers on any metallic base or non combustible base.

Approved colour: grey

Maximum organic content (adhesive): > 99 w/w%

Any additional surface material and adhesive used, other than the one used during testing, has to be tested for low flame spread characteristics according to IMO 2010 FTP Code Part 5 and to be approved according to the Marine Equipment Directive and bear the MED Mark of Conformity.

The product satisfies the requirement for maximum calorific value (SOLAS Reg. II-2/5.3.2.2) without further testing.

Each product is to be supplied with its manual for installation and maintenance.
